Introduction to US CPA

The CPA (Certified Public Accountant) designation is a globally recognized certification in the field of accounting and finance, administered by the American Institute of Certified Public Accountants (AICPA). It signifies expertise in accounting, auditing, taxation, and business law, and is highly regarded in both public and private sectors.

AICPA provides a duration of maximum 3 years, from the date of registration, to complete the US CPA Course.

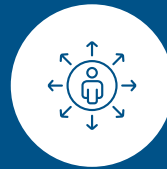

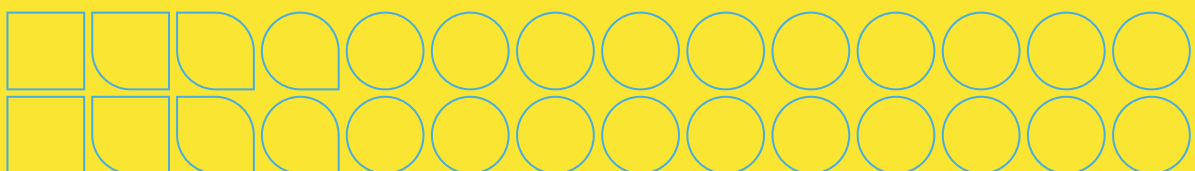

US CPA Eligibility



Requirement for Examination:

- To be eligible for appearing the CPA exams, candidates generally need to have completed 120 credit hours of education.
- Bachelor of Commerce (BCom) degrees or equivalent in UGC-approved universities in India like Mumbai University, Delhi University, IGNOU etc are recognized.
- A typical 3-year undergraduate program, such as a BCom, usually earns 90 credit points- (30 credit points per year).
- To meet the 120 credit point requirement for the CPA exams, students need an additional 30 credit points, which can be obtained after the completion of the first year of the post graduation (PG) course.
- For obtaining the CPA license, an additional 30 credit points are required, which can be fulfilled by completing a postgraduate course / accumulating credit points through other approved courses.
- CA/CMA Certification: Certified Accountants (CA) or Certified Management Accountants (CMA) who have earned 150 credit points are eligible for the CPA exam and license.
- Students from NAAC: BCom qualified students from NAAC Accredited colleges are directly eligible to get 120 credit points.

Requirement for Licensing:

- To obtain a CPA license, candidates must have completed 150 credit hours of education.
- Candidates must obtain 2 years / 2000 hours of work experience in tax, audit, accounting, and consulting.
- Candidates must pass an on demand ethics exam as part of the certification process. It is applicable to some states of US.
